Guarantees

Hips

All puppies bred and whelped at Satilla Training Center carry a Hip Guarantee. This covers any genetic problems which prevent the animal from being certified by the Orthopedic Foundation for Animals (OFA). It is possible to state that any given dog will be completely free of a genetic imperfection. The OFA will only certify dogs who have reached 24 months of age. We offer this guarantee to be honored, the dog MUST be X-rayed and certified within 2 months of reaching 24 months of age. We offer this guarantee providing the purchaser complies with this agreement. If a problem arises before the dog reaches the required age stated herein, the purchaser MUST have the OFA or an experienced vet evaluate the X-rays and send the purchaser a copy of their findings. Also, a copy of the OFA findings must be sent to Satilla Training Center Gunpoint Kennels for their records. When these requirements are met, this Guarantee will be in effect and honored by Satilla Training Center, who will refund the purchase price of your puppy, or the purchaser a replacement puppy. If the price of the replacement puppy is greater than the original puppy purchased, the purchaser will pay the difference. The transportation expenses of a replacement puppy will be assumed by the purchaser. Satilla Training Center will not cover any vet or OFA expenses related to the hip problem.

Eyes

All puppies bred and whelped at Satilla Training Center carry Eye Guarantee. This guarantee covers hereditary retinal problems with the eyes. It is impossible to state that any given dog will be completely free of a genetic imperfection. A hereditary retinal condition is very rare when both parents have a clear CERF rating. Satilla Training Center offers this guarantee, providing the purchaser complies with this agreement. This eye Guarantee is only good for up to 24 months of age. The dog must be checked by a certified, licensed Ophthalmologist if symptoms of this condition are suspected. A copy of the evaluation findings must be sent to Satilla Training Center for their records, and to Satilla Training Center vet of choice for a second evaluation. When these requirements are met, this Guarantee will be in effect and honored by Satilla Training Center, who will refund the purchase price of the puppy, or give the purchaser a replacement puppy. If the price of the replacement puppy is greater than the original puppy purchased, the purchaser will pay the difference. The transportation expenses of a replacement puppy will be assumed by the purchaser. Satilla Training Center will not cover any vet or OFA expenses related to the eye problem.

Health

The puppy you have purchased is guaranteed to be healthy and free from disease as of the purchase date, _____ . In case of illness, the purchaser shall have the puppy examined by a licensed veterinarian within 7 days of receipt of the puppy. In the event that the veterinarian determines that the dog has health problems that cannot be readily resolved and that were present at the time of purchase, Satilla Training Center will pay fifty percent (50%) of the veterinarian expenses. In the event of a terminal illness resulting in the death of the puppy, and occurring within 7 days of the purchase date, Satilla Training Center will refund the puppy purchase price in full.

Note: The above Guarantees are limited only to the hip, eyes and 7 day health of the puppy. Satilla Training Center will not cover other or future problems, or medical expenses of the puppy.
